
Safety

Intended use

The intended use of the Supporto Truss is the treatment of reducible inguinal hernia and athletic support. Another undergarment is not needed while wearing Supporto Truss.

Application



- 1. Pull apart the elastic band. Leave unattached.
- 2. If rupture is protruding, lie down. Reduce rupture size to normal by using the palm of your hand to gently push rupture upward and in. If necessary, cough to locate exact position of rupture opening.

- 3. Step into the Supporto Truss as you would any briefs or undershorts. Pull up into proper fitting position. There are two pads to provide balanced support for reducible inguinal hernia. Center pads on exact rupture opening.
- 4. Stand up straight. Take one end of the elastic band in each hand and pull out and around your back to attach the hook and loop closure firmly. Adjust until the fit is comfortably snug. ENSURE THE PAD IS PLACED AT THE POINT OF RUPTURE.

Removal

To remove Supporto Truss, unfasten the elastic band hook and loop closure and step out of Supporto Truss.

Cleaning and Maintenance

Machine wash Supporto Truss in warm water, gentle cycle, use mild soap. Tumble dry low, slow, short cycle.

▲ NOTICE: DO NOT use detergent or bleach to clean Supporto Truss. DO NOT iron Supporto Truss.

Thirty-Day Limited Warranty
